SUBJECT: Revisions to the Standard Inputs (SI2001E1 and SI2001M1) to provide web site address for State Wage Rates

Standard Inputs, SI2001E1 and SI2001M1 have been revised to include the web site address for the State wage rates. This change would eliminate the need to process the wage rates by mail/fax and will reduce the time and cost.

The revision to SI2001E1 and SI2001M1 is as follows:

Under "SPECIFICATIONS TO BE USED" and under "INCLUDE THE FOLLOWING ATTACHMENTS FOR FHWA FUNDED PROJECTS" where information on wage rate is provided.

THE SECOND PARAGRAPH IS CHANGED TO:

State wage rates may be obtained from the New Jersey Department of Labor (Telephone: 609-292-2259) or by accessing the Department of Labor's web site at <http://www.nj.gov/labor/lasse/lspubcon.html>. The State wage rates in effect at the time of award will be made a part of this Contract, pursuant to Chapter 150, Laws of 1963 (NJSA 34:11-56.25, *et seq.*).
