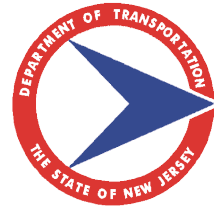

Federal Wage Rate web site & SME contacts

SUBJECT: Provision of web site address for Federal Wages Rates and Revision to Standard Inputs to update the list of SME contacts

Standard Inputs (SI2001E1 and SI2001M1) have been revised to provide a web site address for the Federal wage rates information. This change would eliminate the need to process the Federal wage rates by mail/fax and will reduce the time and the related costs. Also, under Subsection 108.04 instructions in hidden text has been added to include the Pay Item "Progress Schedule" in all projects.

The SI's have also been updated to change the Subject Matter Experts (SME) contacts based on the most recent Department reorganization. Several SI pages revised to reflect revised SMEs are not attached to this BDC announcement to save printing costs. However, the electronic files for both the SIs have been revised for download.

The following revisions have been incorporated in both the English unit Standard Input SI2001E1 and Metric unit Standard Input SI2001M1:

Under "SPECIFICATIONS TO BE USED" and under "INCLUDE THE FOLLOWING ATTACHMENTS FOR FHWA FUNDED PROJECTS" where information on General wage determinations issued under Davis-Bacon is provided.
