**Subject: Revision to *Section 8 Environmental of the Procedures Manual, 8.6.1 Policy on Cost Recovery in Acquisition of Contaminated Property.***

*Subsection 8.6.1* has been revised, in view of the fact that the Manager of Right-of-Way is the Department official vested with the authority to execute real estate agreements on the Department's behalf. The Manager of Right-of-Way is the Department official possessing the authority to determine whether specific clauses in the Agreement are to be modified or waived.

Therefore, under the heading *Procedure for Waiver of Environmental Clauses in Agreements*, the last sentence of the second paragraph which states, "the authority to waive environmental clauses shall rest with the Project Manager or his designee" is revised as shown on new sheet 8.6-6.

To incorporate this change in the Procedure Manual:

Replace pages **8.6-6** and **8.6-7** with attached new **Pages 8.6-6** and **8.6-7**.
