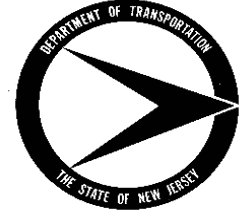

1998 Supplemental Specification to the
1996 Standard Specifications

Subject: Revision to the 1998 Supplemental Specifications to the 1996 Standard Specifications, Subsection 101.03 and Subsection 108.19 Lane Occupancy Charge and release of Interim Policy on Lane Occupancy Charge and Daily Road User Costs

Section 108 of the 1998 Supplemental Specifications to the 1996 Standard Specifications has been revised to add a new Subsection 108.19 Lane Occupancy Charges. In conjunction with this revision, a term has also been added to Subsection 101.03.

The intent of this revision is to ensure that the lanes occupied by the contractor for construction works are reopened to the traveling public immediately after the allowable lane closure hours as specified in the contract document. If the contractor continues to occupy lanes beyond the allowable lane closure hours, the Department will impose specified Lane Occupancy Charges. If the contractor reopens the lane to the traveling public within the first fifteen minutes of the delay, no Lane Occupancy Charges will be imposed. However, any further delay will result into per minute delay charges in addition to the first fifteen minutes of grace extension.

The charges per lane per minute to be specified on a project will be calculated in accordance with the attached guidelines.

Instructions to the Designer

Effective immediately, this revision shall be included in all Department projects. The Technical Specifications unit will incorporate these revisions in the Special Provisions, therefore, the designers do not need to insert these changes.

These revised specifications and the Interim policy on Lane Occupancy Charges and Daily User Costs shall not be used after November 15, 1999, it is expected that the final policy will be prepared and released prior to that date.

Corrective Action Notice, CAN0017, dated March 18, 1999 is hereby superseded.
