**Subject: Revisions to Procedures Manual, Section 4.3, for the Developing and Processing Construction Schedules**

**Reference: Refer to [BDC01T-5](#) dated February 26, 2002 and [BDC01S-12](#) dated February 27, 2002 for related information**

The procedures for developing and processing of construction schedules have been revised to utilize the publication entitled *Construction Scheduling Standard Coding and Procedures for Designers and Contractors Manual* that was issued by BDC01T-5, (dated 2/26/02). Therefore, Subsection 4.3-1 Construction Schedule, of the Procedures Manual has been revised to reference the use of this document for developing and processing construction schedules for all Department projects.

The revisions to existing Section 4.3 affects pages 4.3-8 through 4.3-15 and 4.3-28 through 4.3-30. All the revisions to this Section are included on page 4.3-8 as one paragraph. This would have resulted in deleting pages 4.3-9 through 4.3-15 and 4.3-28 through 4.3-30 and renumbering 4.3-16 through 4.3-33. In order to avoid this editing that would result in issuing pages not related to the subject, pages 4.3-9 through 4.3-15 and 4.3-28 through 4.3-30 are hereby **DELETED**. However, the owners are advised to delete existing pages 4.3-9 through 4.3-15 and 4.3-28 through 4.3-30 in their copy of the manual. It is suggested to cross out all text with an "X" and state "DELETED BY BDC01PR-3" on each deleted page.

To incorporate these changes to the NJDOT Procedures Manual do the following:

Replace existing page **4.3-8** with the new page **4.3-8** and delete existing pages 4.3-9 through 4.3-15 and 4.3-28 through 4.3-30.

**Instructions to Designers and Contractors:**

This BDC is one of three BDC's for developing and processing of construction schedules. The other two BDC's, BDC01T-5 (dated 2/26/02) and BDC01S-12 (dated 2/27/02), are for the construction schedule manual and revised specifications, respectively.

The requirements of these three BDCs shall be followed by designers and contractors to develop construction schedules for projects that are designed using either the Department's 2001 metric or English units Standard Specifications for Road and Bridge Construction.
