**SUBJECT: Revision to Subsection 202.15 of the 2001 Standard Specifications for Road and Bridge Construction in English and Metric units**

Subsection 202.15 (Basis of Payment) of the 2001 Standard Specifications for Road and Bridge Construction in English and Metric units have been revised to clarify that the payment for Sawcutting has always been included in Joint Removal or Removal of Concrete Base Course and Concrete Surface Courses Pay Items. When the 2001 Standard Specifications were issued the wording was inadvertently changed to have the Pay Item Sawcutting paid separately. The addition of this clause to 202.15 will then have Sawcutting included in the payment for the above stated Pay Items.

The following revisions have been incorporated in both the English unit Standard Input SI2001E1 and Metric unit Standard Input SI2001M1:

**SECTION 202 - ROADWAY EXCAVATION**

**202.15 Basis of Payment.  
THE FOLLOWING IS ADDED**

Separate payment will not be made for Sawcutting when used with the Pay Items "Joint Removal" or "Removal of Concrete Base Course and Concrete Surface Courses".

**Instructions to Designers:**

The above specification revision shall be included on all Department projects requiring Roadway Excavation that are scheduled for Final Submission after April 1, 2003 and are designed using the *English or Metric 2001 Standard Specifications*. The specification revision has been incorporated in the Standard Inputs *SI2001E1* and *SI2001M1* updated as of March 17, 2003.
