Revenues Fall \$492 Million Below Budget Forecast for Fiscal 2010

TRENTON – State Treasurer Andrew P. Sidamon-Eristoff announced that revenue collections during the month of April fell \$568 million short of projections. Revenues for the first 10 months of the fiscal year ran \$492 million, or 2.2 percent, below estimates.

"I caution against reading too much into April's revenue figures. While April is usually the crucial month for revenue collections, May could be just as important this year. We won't have a true picture until later this month," Treasurer Eristoff said. "New Jersey, like the federal government, allowed businesses and residents of 15 counties devastated by flooding to delay filing tax returns and payments until May 11. I expect that fact to be reflected in May collections."

Income tax collections totaled \$1.6 billion for the month of April, 26 percent below the budget forecast that was made in February. At the same time, sales tax collections were 6 percent higher than budgeted, and the corporation business tax generated 11 percent less revenue than forecast.

"New Jersey is struggling during a time of historic economic uncertainty," Treasurer Eristoff said. "Planning for any scenario other than continued disappointment in revenue collections would be fiscally irresponsible."

For the first 10 months of the year, income tax collections are on track to be 5.6 percent below amounts in the budget that was revised in February. Sales taxes collections are running less than 1 percent below budgeted amounts for the fiscal year. Corporate business tax collections are on track to match forecasts.
