PURPOSE

To encourage FFA Chapters and recognize their public relations efforts during FFA Week. Every FFA Chapter should make a local effort to take advantage of the nationwide FFA Week celebration to gain awareness in their community of agricultural education and the FFA. FFA Week is held in February each year.

RESOURCES

The National FFA Organization sends a packet of FFA Week ideas to every chapter each year. A theme is selected for the year and should be incorporated into the week's promotional activities and events.

RULES

1. Only chartered FFA Chapters may enter this event with one application per chapter.
2. Only promotional activities conducted for FFA Week during the month of February will be considered for recognition.
3. The application for this event will be due April 1 for activities of the immediate past FFA Week.
4. All activities reported must be the result of the effort put forth by the chapter reporting on this application.
5. All activities reported on this application must be verified by supporting evidence such as: news articles, samples, pictures, or one paragraph descriptions. These should be placed in a report binder in the back of the application.
6. Activities should attempt to reach as many people and involve as many FFA members as possible.
7. Original ideas for FFA Week will give a chapter additional points toward the final selection.

- First Place: \$100 award
- Second Place: \$50 award
- Third Place: \$25 award
