# 2025 Proposed Amendments for the 2025 National FFA Constitution Amendments

# Submitted by the National Board of Directors and 2024-2025 National FFA Officers

SUBJECT #1: Replacing language to shift from individual member dues to universal chapter affiliation fees.

**MOTION:** Move to amend the National FFA Constitution including:

- 1. Article IV. Procedures for Determining Standing of State Associations and Chapters, Section A, Item 1 by removing the words "dues or". (Reference Line 80)
- 2. Article IV. Procedures for Determining Standing of State Associations and Chapters, Section B, Item 1 by removing the words "dues or". (Reference Line 102)
- 3. Article V. Membership, Section B by removing items 2 and 3, renumbering item 4 to be number 2 and revising language to read, "Display conduct consistent with the ideals outlined in the Code of Conduct, which includes the Code of Ethics, Value Statements, FFA Code of Behaviors, and purposes of the National FFA Organization." (Reference Lines 139-144)
- 4. Article V. Membership, Section B by adding the language, "Upon being granted FFA membership, students are encouraged to strive for active engagement in the activities and operations of the local chapter." (Reference Lines 147 and 148)
- 5. Article V. Membership, Section B by removing the words, "payment of dues or" and "paying dues and" (Reference Lines 155 and 161)
- 6. Article VI. Degrees and Privileges of membership, Section A by inserting the words, "for all members that meet the membership requirements in Article V., Section B and are listed on a local chapter's membership roster." (Reference Lines 174-176)
- 7. Article VI. Degrees and Privileges of membership, Section B by deleting Item 2 and renumbering the remaining Items. (Reference Lines 188 and 189)
- 8. Article VI. Degrees and Privileges of membership, Section E by deleting, "and paid membership dues" from Item 2. (Reference Line 239)
- 9. Article XIV. Dues by replacing "Dues' with "Program Affiliation" (Reference Line 512)
- 10. Article XIV. Dues, Section A by deleting "membership dues and" and "dues and" throughout Section. (Reference Lines 515, 517, 518, and 520)
- 11. Article XIV. Dues, Section C by deleting "membership dues and" (Reference Line 527)
- 12. Article XIV. Dues, Section D by deleting "The annual membership dues and program affiliation fees of a chapter shall be established by a majority vote of the members at a regular chapter meeting." and inserting, "A local chapter may not charge a per-member fee or impose a participation requirement that solely determines an individual's membership status within the chapter. Chapters retain the right to raise, collect, manage, and allocate funds to support chapter activities, and operations, as long as these funds are not tied to determining FFA membership eligibility." Reference Line 531-538)

### **RATIONALE:**

- Full affiliation reaffirms that FFA is an integral and intracurricular component of agricultural education. Every enrolled student is an FFA member, providing the teacher the opportunity to engage all students in the school-based agricultural education three-component model.
- This proposal meets the Guiding Design Principles established by the Board Committee for Membership of: (1) Simplifying the current program affiliation options and process; (2) Moving FFA

to a chapter-based instead of a member-based fee; (3) Accounting for existing chapter and state participation in affiliation; (4) Providing financial viability for FFA at the local, state and national level; and, (5) Allowing state flexibility in implementation.

- The current use of affiliation and the traditional per-member dues structure has resulted in a
  disparity in the cost of access to FFA for members and chapters. The tiered, chapter-based fee would
  eliminate that disparity and give all chapters equal access to FFA membership for all SBAE students.
- The delegates of the Student Perspectives on Affiliation Committee of the 96th National FFA Convention and Expo encouraged the National FFA Board of Directors to continue to explore the adoption of the tiered model as National FFA proceeded with the adoption of 100% affiliation.
- The amendments to Article V. Membership, Section B were designed to: (1) encourage active engagement by members while not making meeting attendance and individual payment of dues a requirement of membership; and (2) provide clarification on the ideals of the organization and expected behavior to support teachers and state leaders in the event that a member needs to have membership revoked due to inappropriate behavior.
- The amendments to Article XIV. Dues, Section D were designed to clarify the ability of local chapters to still meet their annual financial needs with the limitation of not imposing a per-member fee that is a requirement for membership.

#### Effect:

The proposed amendments would move FFA at all levels to a chapter-based fee instead of a member-based fee that would include all students enrolled in each school-based agricultural education program. Ultimately, the proposal removes individual student dues as a barrier to membership and engagement.

# STATE FFA EXECUTIVE BOARD RECOMMENDATION:

The State FFA Executive Board recommends voting in favor of this amendment.

# Useful Information for the Delegate Business Session

# The Meaning of "Motion"

The primary purpose of the delegate business session is for the delegates to make decisions. To begin the process of making any decision, a member offers a proposal by "making a motion." A **motion** is a formal proposal by a member, in a meeting, that the group take a certain action.

# How a motion gets before a group

### How to make a main motion

- 1. Raise your delegate card.
- 2. Be recognized by the chair.
- 3. State your name and chapter.
- 4. State "I move that..." or "I move to..." and then clearly describe the proposal. It is important to say precisely what the words of the motion are to be. The group votes on exact language, not a vague idea.

# How to second a motion

Once a member makes a main motion, it must be seconded to be considered by the group. This shows that at least two members want the motion considered. If there is no second, the motion dies and is not put before the group for discussion.

- 1. Raise your delegate card.
- 2. Be recognized by the chair.
- 3. State your name and chapter.
- 4. State "I second the motion" or "Second"

# Some other motions you may hear in the delegate business session

### **Amendments**

Amendments are used to modify the wording, and within limits, the meaning of the motion on the floor. Amendments should say exactly where the change is to be made and precisely what words to use. To make this motion, you would state "I move to amend the main motion by . ." and then you would identify what you want to do. This action can include adding words, striking out words or adding and striking out words. An amendment may not change the original intent of the motion. The vote on the amendment does not decide whether the motion will be adopted, only whether the wording in the motion will be changed. After an amendment is adopted, the motion as amended can be further debated. If an amendment is adopted, a vote will be taken on the main motion as amended. Only if the motion as amended passes will the group decide to do what was proposed.

# **Previous Question**

The adoption of previous question immediately closes debate and also prevents the making of any amendments. It may be made at any time while a debatable amendment is on the floor. Since it limits a member's rights, the motion for previous question requires a two-thirds vote. It is not debatable. The proper wording to close debate and immediately vote on the motion on the floor is to say, "I move the previous question." If previous question passes, the main motion will get voted on immediately. If previous question fails, discussion may continue on the main motion before voting on it.

# Division of the House

When you, as a delegate, reasonably doubt the result of a voice vote, you have the right to demand that the vote be re-taken as a counted vote, by calling division of the house. Immediately following the vote and prior to the next action of the chair, you would call out "Division of the house." No second is needed and once called the chair proceeds to give directions for a counted vote.

# Voting

# Majority

A **majority vote** is normally required to adopt a motion or to elect office. It is defined as "one more than half of the votes cast by persons legally entitled to vote." The result of a majority vote is decided through a voice vote.

### Two-thirds

A two-thirds vote is required in particular circumstances, most notably to suspend the rules or to limit, extend, or close debate. It is defined as "at least two-thirds of the votes cast by persons legally entitled to vote." Whenever a two-thirds vote is required to pass a motion, the chair will take a standing vote.
