C. National Leadership Conference for State Officers (July 28-August 1, 2013)

On our way to NLCSO, we stopped for Agricultural tours of local farms. We visited Dusty Lanes Farm where we learned about harvesting potatoes. We also visited Coombs Sod Farm where we learned about farm equipment, and the benefits of sod. We also visited A Garden Party Florist. At Helena Chemical, we saw how technology could be used to map out nutrient imbalances of a field. We visited a peach orchard and farm market, as well as Koi farm.
