MINUTES OF DECEMBER 11, 2023 MEETING

On motion by Ms. Davis, second by Mr. Lomax, the minutes of the December 11, 2023 meeting were approved.

CHAIRMAN'S COMMENTS

Mr. Atchison reported on the following:

- 1. Deer fence and SADC appraisal regulations are on the Governor's desk for signature.
- 2. The NJ Ag. Convention will be held at Harrah's in Atlantic City, February 7th to the 8th.

EXECUTIVE SECRETARY'S REPORT

- 1. **Supervisor Appointment (Gloucester)-** On motion by Mr. Lomax, second by Mr. Rigolizzo, Dan Brown was chosen to fill a vacancy on the Gloucester County Soil Conservation District Board
- 2. **District Self-Assessment-** All 14 Districts submitted the required self-assessment forms. These forms are being reviewed and summarized.
- 3. **District Audits** Policy dictates all District audits be submitted to the State office 120 days from the start of the new fiscal year. There are several outstanding audits.

SOIL EROSION AND SEDIMENT CONTROL ACT

- 1. **2:90 Rules-** These regulations sunset every 7 years. They are set to expire November 2024. Updates, modifications and changes to these regulations need to be completed by March so there is enough time to go through legal review, publication, public comment period, etc.
- 2. **Engineering Report-** Mr. Showler provided a brief overview regarding the 2023 Erosion Control Program Value. Concluding with year 2023, the program has prevented the loss of an estimated 32,202,637 tons of soil from construction sites across New Jersey. This has resulted in an estimated cost savings to the public of approximately \$1.6 billion. Comparing this savings to NJ conservation district fees for that time period (approximately \$236.5 million) yields a benefit to cost ratio of about 6.7:1.

NATURAL RESOURCE CONSERVATION SERVICE

Mr. Madlinger reported on the following:

- 1. In FY '23, NJ-NRCS funded 288 EQIP contracts for a total of \$8.9 million. In addition, 14 AMA contracts were funded for a total of \$520,000, 9 CSP contracts for \$201,380 and 99 Forest Management plans were funded.
- 2. For FY '24, to date, 612 applications have been received. \$8.3 million has been pre-approved.
- 3. The HEP local work group met Jan. 3rd. The Morris Local Work Group meets Jan, 10th and the Cape-Atlantic Local Work Group meets Jan. 16th and 18th.
- 4. Tai Colon has been hired to fill the position of Outreach Coordinator.
- 5. The new Acting State Conservationist is Erika Boyland from Arizona.

NJ ASSOCIATION OF CONSERVATION DISTRICTS

Mr. Dovey and Mr. Cywinski reported on the activities of the NJACD and NACD including the following:

- 1. Dates for 2024 Regional Supervisor meetings will be discussed at the afternoon NJACD meeting.
- 2. The upcoming legislative Outreach trip to Washington DC is being planned.
- 3. The 2024 NJACD budget is being drawn up.
- 4. Discussions are ongoing regarding the possibility of hiring a part-time Executive Director for NJACD.
- 5. Elizabeth Hite Vollavanh (HEP SCD) was awarded a scholarship to attend the upcoming NACD Annual Conference.

DISTRICT EMPLOYEES ASSOCIATION

Mr. D'Alessandro reported that a meeting is scheduled for Jan. 11th to discuss goals, and training needs of the Employees Association. In addition, a training meeting is scheduled for Feb. 26th at the Freehold SCD office for 251 plan review.

DEPARTMENT OF ENVIRONMENTAL PROTECTION

Mr. Contois reported on the following:

- 1. No updates regarding the NJ Flood Hazard regulations.
- 2. NJ-DEP is struggling to retain employees and fill vacancies.

RUTGERS COOPERATIVE EXTENSION

Mr. Haberland reported on the following:

- 1. Ruth Carl was hired to fill the position of Statewide Consumer Horticulturist.
- 2. Interviews will be set up for the vacant Essex County Extension position.
- 3. The search is ongoing to fill the Warren County agricultural agent position.
- 4. The statewide fruit IPM Agent will start March 1st.
- 5. A search will be underway shortly for a new County Agent in Salem County.

SCHOOL OF ENVIRONMENTAL AND BIOLOGICAL SCIENCES

Dr. Murphy reported on the following:

- 1. Classes start next week.
- 2. There will be a Soil Health presentation at the upcoming NJ Ag. Convention.

PUBLIC AND AGENCY COMMENTS

Noel? from USDA? Reported on "Birth of Discrimination", which is a USDA reparation outreach program for minority and underserved individuals who feel they have been discriminated by USDA over the years. There is still approximately \$2.2 billion in the program. Applications must be postmarked by Jan. 13, 2024.
