**SUBJECT:** MEMO #24-01 FDC – Reimbursement Rates Effective July 1, 2023 – June 30, 2024

The United States Department of Agriculture (USDA) has published CACFP Reimbursement Rates for the period of July 1, 2023, through June 30, 2024, for meals served in Day Care Homes and for the administrative payments for Sponsoring Organizations of Day Care Homes.

This year’s reimbursement rates reflect an increase from the 2022-2023 base rates for Administrative Payment rates for Sponsoring Organizations for each sponsored day care home and an increase in Food Service Payment Rates for Day Care Homes. Food Service Payment rates increased by 9 cents for Tier I breakfast meals and increased by 3 cents for Tier II breakfast meals. Lunch and Supper Payment rates increased by 18 cents for Tier I lunch and supper meals and by 10 cents for Tier II lunch and supper meals. Snack Payment rates increased by 6 cents for Tier I snack meals and by 1 cent for Tier II snack meals.
