


Re: Federal Milk Order Amendment- Class I and Presumptive Prices

On June 1st, 2025, amendments to the Federal Marketing order will be put into effect. These changes impact both the pricing formulas and zone delineations. In response to the new amendments the New Jersey Department of Agriculture will be variable cost and presumptive prices. The two zones will be the **\$5.00 Newark/Metropolitan Zone** pricing and will be used in the counties of Passaic, Bergen, Morris, Essex, Union, Somerset Middlesex, Monmouth and Ocean counties. The **\$4.70 suburban/rural zone** pricing will be used in the counties of Sussex, Warren, Hunterdon, Mercer, Burlington, Camden, Gloucester, Atlantic, Salem, Cumberland and Cape May.

Effective June 1, 2025, there will no longer be North and South Jersey presumptive prices, as it will be replaced by the **Metropolitan and Suburban/Rural** pricing structure. Please review and verify pricing at all levels with your staff and stores.

Price includes the 20 cent per hundredweight Milk PEP assessment authorized under the Fluid Milk Promotion Act of 1990, which mandated a 20 cent assessment on all fluid milk products processed and marketed commercially in consumer type packages.

Price includes the New Jersey Fuel Adjuster add-on for Class I utilization pricing.

June Class I Fuel Adjuster is \$0.73 per hundredweight.

The current administrative assessment levied on processors by the Market Administrator is 4.5 cents per hundredweight.

#Cost represents the converted cost of the raw milk in various size containers. These costs do not include any associated processing, packaging, transportation, profit margin or other cost factors associated with processing milk.
