## **Justification for Gutterhouse Greenhouse Roof Replacement**

The New Jersey Department of Agriculture Beneficial Insect laboratory requires the replacement of the greenhouse roof panels in Ewing New Jersey. The Gutter Connected Poly Greenhouses are known for their superior airflow and temperature control and are suitable for multiple and varied vegetable crops, plants, and flower crops that are needed for the rearing of beneficial insects. The roofs maximize condensation control with single-piece arch construction rolled to form Gothic peaks. The steeper peak also assists in shedding ice and snow more efficiently than Quonset arches. Due to age and storm damage the greenhouse roof panels are failing and require replacement. The roof is original to the structure and showing signs of failure and collapse (see photos below). The NJDA Plant Industry is requesting a quote for the replacement of all roof panels and materials, as well as any related support structure and materials that will hinder the functionality of the new roof. NJDA plant industry is requesting that the replacement panels be of equal or greater quality than the original panels when new. NJDA plant industry is requesting that all vendors also supply the terms of the warranty for the panels and workmanship. NJDA is expecting a minimum warranty of 10 years materials and workmanship or better. The quote should also provide spare panels for attic stock. The spares should equal to a 10% of the roofing area. Exterior greenhouse dimensions are 60'-6" x 53'-8". Optimal time for replacement should be Oct – April.
