### **IN THE MATTER OF THE BOARD'S REVIEW OF THE PROVISIONS OF N.J.A.C. 14:1 et seq. and N.J.A.C. 14:17 et seq. TO FULLY IMPLEMENT THE BOARD'S E-FILING PROGRAM - DOCKET NO. AX16080751**

On July 29, 2016, the Board approved an order waiving the provisions of N.J.A.C. 14:4-2(a) and N.J.A.C. 14:17-4.2(a), requiring the submission of an original and 10 conformed copies of each pleading(s) if the party chooses to electronically file ("e-file"), and N.J.A.C. 14:1-1.6(c) and N.J.A.C. 14:17-1.6(d), prohibiting the submission of an electronic document from being entered into the record of a formal proceeding.

This waiver is limited to the filing of a petition, tariff filings, and other such documents by a public utility company that pays an annual assessment pursuant to N.J.S.A. 48:2-59 or a cable company that pays an annual assessment pursuant to N.J.S.A. 48:5A-32 ("Assessed Entity").


