**New Jersey Board of Public Utilities Commissioner Randall
to Recognize Glatt Air Techniques for Energy Reduction Leadership**
Check presentation to be made for company's exemplary dedication to environment

(NEWARK, NJ) – New Jersey Board of Public Utilities (NJBPU) Commissioner Elizabeth Randall will attend a special ceremony beginning 1 p.m. on Tuesday, December 9, 2008, to recognize Glatt Air Techniques. During the ceremony, Commissioner Randall will present Glatt Air executives with an incentive check for \$88,000 for the company's targeted reduction of energy usage in two primary areas: lighting and heat recovery.

Glatt Air worked with NJ SmartStart[®] Buildings (the commercial and industrial component of the NJ Clean Energy Program) to finance an upgraded lighting and control system that is expected to result in 184,630 kWh of annual energy savings, 58.18 kW of electricity demand reduction and savings of nearly \$25,000 each year. Glatt Air also installed two heat recovery units along with an Encelium Building Automation System expected to produce annual energy savings of 109,704 kWh, 33.11 kW demand reduction and 680 million Btus of natural gas savings. Glatt estimates annual utility bill reductions from the heat recovery and building automation system to reach \$19,000.

Public officials and other guests invited to the ceremony include various state, county and local officials, among others.

From New York City (Southeast)

- Cross over George Washington Bridge to enter New Jersey
- Merge onto I-95 South
- Take the 1-95 South exit toward NJ Turnpike/I-80/Hackensack/State Hwy 4/Garden State Pkwy
- Take exit 72A for State Hwy 4 West toward Paramus
- Merge onto RT 4 and continue to follow for approximately 6.5 miles
- Take the State Hwy 17 North exit toward Garden State Parkway
- Merge onto RT 17 North and continue to follow for approximately 10 miles
- Slight right at Lake Street
- Turn left at Spear Road

From Philadelphia (Southwest)

- Cross over Ben Franklin Bridge (676 East) to enter New Jersey
- Slight left at US 30 East (signs for Trenton/US 130/US 30 East/NJ Turnpike)
- Slight left at RT 38/Kaighns Avenue. Another slight left to continue to follow RT 38
- After 5 miles, make a slight right toward RT 73 (signs for NJ Turnpike/Marlton/RT 73)
- Slight left to merge onto RT 73 South
- Take the NJ Turnpike ramp
- Keep left at the fork to continue toward NJ Turnpike North and merge onto roadway
- Take the exit on the left toward I-80 West/Hackensack/Paterson
- Merge onto I-80 West
- Take the exit on I-80 West toward Hackensack
- Take exit 64A for State Hwy 17 North toward Paramus/Rochelle Park/State Hwy 4
- Merge onto RT 17/North State RT 17
- Slight right at Lake Street
- Turn left at Spear Road

From Edison, NJ (South)

- Merge onto Garden State Parkway North
- Take exit 161 for State Hwy 4 East toward Paramus
- Keep left at the fork to continue toward RT 17 North
- Keep left at the next fork, follow signs for State Hwy 17 North and merge onto RT 17 North
- Slight right at Lake Street
- Turn left at Spear Road
- Slight right to stay on Spear Road
