On January 18, 2012, the Board of Public Utilities ("Board"), in response to Governor Christie's conditional veto of A3991/S2978, initiated "a review of the safety implications of the installation and maintenance of solar and photovoltaic electric generation equipment by electric public utilities in the "neutral" zone on utility poles...." As presiding officer in this matter, I have the authority to issue a schedule in this matter and to control the conduct of this review.

On Friday, February 10, 2012, a request for an extension of time to file comments was submitted by Dennis Linken on behalf of the New Jersey Cable Telecommunications Association (NJCTA). In the interest of establishing a full and complete record in this matter, I HEREBY GRANT the request for an extension of time to file comments to the NJCTA, and, in fairness, to all others planning to file comments.
