Pursuant to the "Open Public Meetings Act", N.J.S.A. 10:4-6 et seq, the New Jersey Board of Public Utilities ("Board") hereby gives notice of a Public Meeting to discuss the following item:

In the Matter of the Provision of Basic Generation Service ("BGS")
for the Period Beginning June 1, 2012 – Docket No. EO11040250

The "legislative-type" hearing in this docket will be held on September 26, 2011 from 10:00 a.m. – 2:00 p.m. at the Board's Office at 44 S. Clinton Avenue – 1st Floor, Board Room, Trenton, New Jersey. The purpose of the hearing is to take comments on the Electric Distribution Companies' BGS proposals filed on July 1, 2011, as well as on any alternative BGS proposals filed by interested stakeholders. The hearing will be chaired by President Lee Solomon.

For those unfamiliar with the process, interested parties will be allowed a fixed amount of time to present their comments, after which the Commissioner may have some clarifying questions. The amount of time allotted will be determined by the Commissioner at the hearing.

Final Comments on the procurement proposals will be due on Friday, September 30, 2011. Final Comments should only be used to respond to issues raised in the Initial Comments, issues raised at the Legislative-type hearing or questions issued by Board staff as part of this matter. They should not be used to raise new issues in this proceeding.
