For a Statewide Collection System wastewater customer using 5,642 gallons of water per month, the monthly impact will be an increase of \$5.12.

- D. Docket No. WR24040240 – In the Matter of the Petition of New Jersey-American Water Company, Inc. for Authorization to Implement a Resiliency and Environmental System Investment Charge.

The Board will consider New Jersey-American Water Company, Inc.'s request to establish a Resiliency and Environmental System Improvement Charge ("RESIC") pursuant to N.J.S.A 48:19-29 et seq. The parties executed a stipulation which, if approved by the Board, would result in a maximum monthly RESIC surcharge of \$2.32 for a residential customer with a 5/8 inch meter.

- E. Docket No. WR24030187 – In the Matter of the Petition of New Jersey-American Water Company, Inc. for Authorization to Implement a Distribution System Improvement Charge.

The Board will consider New Jersey-American Water Company's request for Authorization to Implement a Distribution System Improvement Charge ("DSIC"). If approved, the DSIC would result in a maximum monthly DSIC surcharge of \$4.68 for a residential customer with a 5/8 inch meter.
