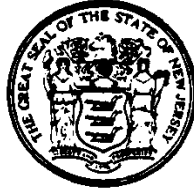

2. REVENUE AND RATES

- A.** Docket No. WR25060330 – In the Matter of the New Jersey Board of Public Utilities’ Consideration of the Gross Receipts Tax on Water and Sewer Utilities – Aqua New Jersey, Inc.

The Board will consider Aqua New Jersey, Inc.’s petition seeking deferred accounting treatment of refunds related to Gross Receipts Tax. The parties have executed a stipulation, which would result in no immediate impact to customers.

- B.** Docket No. WR25050313 – In the Matter of the New Jersey Board of Public Utilities’ Consideration of the Gross Receipts Tax on Water and Sewer Utilities – Middlesex Water Company.

The Board will consider Middlesex Water Company’s petition seeking deferred accounting treatment of refunds related to Gross Receipts Tax. The parties have executed a stipulation, which would result in a Middlesex residential customer with a 5/8” meter, receiving an estimated one (1)-time bill credit of \$26.52.

- C. Docket Nos. BPU WR25060372 and OAL PUC 12680-25S – In the Matter of the Joint Petition for an Approval of an Increase in Rates for Water and Wastewater Service and Other Tariff Changes for Middlesex Water Company, Pinelands Water Company, and Pinelands Wastewater Company.

The Board will consider the June 2025 base rate case filing made by Middlesex Water Company, Pinelands Water Company, and Pinelands Wastewater. Several parties executed a stipulation which was approved by Administrative Law Judge Jacob S. Gertsman. The stipulation, if approved, would result in the following quarterly bill increases for the average residential customer: 1) \$21.92 for Middlesex; 2) \$20.51 for Pinelands Water; and 3) \$67.49 for Pinelands Wastewater.

- D. Docket No. EO26020023 – In the Matter of the Request for Quotation Regarding Implementation of Executive Order 1 – **Executive Session.**

The Board will consider releasing a Request for Quotation to retain a consultant related to the implementation of Executive Order 1.

3. ENGINEERING

- A. Docket No. WR25070451 – In the Matter of the Joint Petition of Middlesex Water Company, Pinelands Water Company, and Pinelands Wastewater Company for Approval of a Foundational Filing for Establishing a Resiliency and Environmental System Improvement Charge.

The Board will consider the Middlesex Water, Pinelands Water Company and Pinelands Wastewater Company's request to establish a Resiliency and Environmental System Improvement Charge ("RESIC") pursuant to N.J.S.A. 48:19-29 et seq. The parties executed a stipulation which, if approved by the Board, would result in a maximum monthly RESIC surcharge of \$1.97 for a residential customer using a 5/8-inch meter.

- B. Docket No. WR25070452 – In the Matter of the Joint Petition of Middlesex Water Company and Pinelands Water Company for Approval of a Foundational Filing for Establishing a Distribution System Improvement Charge.

The Board will consider Middlesex Water and Pinelands Water Company's request to establish a Distribution System Improvement Charge ("DSIC") pursuant to N.J.A.C. 14:9-10 et seq. The parties executed a stipulation which if approved by the Board, would result in a maximum monthly DSIC surcharge of \$3.96 for a residential customer using a 5/8-inch meter.

- C. Docket No. EO25080476 – In the Matter of the Petition of Better View Homes Inc., a Corporation of the State of New Jersey.

The Board will consider a petition filed requesting an exemption of the requirements of N.J.A.C. 14:3-8.4(d) of the Main Extension Rule.
