BY THE BOARD:

On March 19, 2012, Neil and Jennifer Boyle ("Petitioners") filed with the Board of Public Utilities ("Board") a petition disputing billing charges associated with electric service provided by Public Service Electric and Gas Company ("Respondent").

On April 3, 2012, after the filing of Respondent's answer, the Board transmitted this matter to the Office of Administrative Law ("OAL") as a contested case for hearing and initial disposition pursuant to N.J.S.A. 52:14B-1 et seq. and N.J.S.A. 52:14F-1 et seq. This case was assigned to Administrative Law Judge ("ALJ") Tiffany M. Williams.


While this matter was pending at the OAL, the parties engaged in negotiations and entered into and signed a Stipulation of Settlement ("Stipulation") that was submitted to the ALJ. Pursuant to the terms of the Stipulation, and in order to fully resolve this matter, Respondent has agreed to credit Petitioners' electric and gas account in the amount of \$753.30. By Initial Decision issued on August 27, 2012 and submitted to the Board on August 30, 2012, to which the Stipulation was attached and made a part thereof, ALJ Williams found that the Stipulation was voluntary, that its terms fully disposed of all issues in controversy, thus satisfying the requirements of N.J.A.C. 1:1-19.1.

After review of the record and the Stipulation of the parties, the Board HEREBY FINDS that the parties have voluntarily agreed to the settlement as evidenced by their signatures, and that by the terms of the Stipulation, they have fully resolved all outstanding contested issues in this


matter. Accordingly, the Board HEREBY ADOPTS the Initial Decision and Stipulation executed by the parties in their entirety as if fully set forth herein.





A hearing date was scheduled for September 21, 2012 but adjourned because the parties agreed to settle the matter. The Stipulation of Settlement indicating the terms of settlement was signed by the parties and is attached hereto.

The parties have voluntarily agreed to the settlement as evidenced by the signatures of the parties or their representatives.


2. The settlement fully disposes of all issues in controversy and is consistent with law.

On or about April 3, 2012 Petitioners filed the above-referenced billing dispute. Public Service Electric & Gas Company ("PSE&G" or "Respondent") filed an answer to Petitioners' petition and the New Jersey Board of Public Utilities ("NJBPU" or "Board") transmitted the matter to the Office of Administrative Law ("OAL") as a contested case for adjudication.

In the interests of resolving this matter without further delay, extensive effort and cost, the parties hereto agreed to settle this matter in accordance with the following terms:


1. PSE&G agrees to credit \$753.30 to Petitioners' account for electric and gas service.
2. This agreement is in settlement of the Petition filed by Petitioners on or about April 3, 2012.
3. The undersigned agree that this Settlement contains mutually balancing and interdependent provisions and is intended to be accepted and approved in its entirety. In the event any particular aspect of this Settlement is not accepted and approved by the Board or modified by the Board, the party that is adversely affected by the modification can either accept the modification or declare this Settlement to be null and void, and the parties shall be placed in the same position that they were in immediately prior to its execution.
