
BY THE BOARD:

The Initial Decision of Administrative Law Judge Jacob S. Gertsman was received by the Board of Public Utilities ("Board") on March 3, 2021; therefore, the 45-day statutory period for the reviewing and issuing of a Final Decision expired on April 7, 2021. On April 7, 2021, the Board the Board issued an Order of Extension requesting an additional 45-day extension of time for issuing the Final Decision in order to adequately review the extensive record in this matter. The Office of Administrative Law granted the Board's request on April 8, 2021, thus extending the 45-day statutory period for review and issuing of a Final Decision until May 22, 2021.

The parties have unanimously consented to an extension of time to issue the Final Decision, pursuant to N.J.S.A. 52:14B-10(c) and N.J.A.C. 1:1-18.8(e), and for other good cause shown, **IT IS ORDERED** that the time limit for the Board to render a Final Decision is extended until July 6 2021.
