BY THE BOARD:

Administrative Law Judge Jacob S. Gertsman’s Initial Decision in this matter was received by the New Jersey Board of Public Utilities (“Board”) on September 29, 2022. Therefore, the 45-day statutory period for the Board to review and issue a Final Decision will expire on November 14, 2022. Prior to that date, Board Staff requested an additional 45-day extension of time to adequately review the record and provide recommendations to the Board.
