Administrative Law Judge Jacob S. Gertsman's Initial Decision in this matter was received by the New Jersey Board of Public Utilities ("Board") on September 29, 2022. Therefore, the 45-day statutory period for the Board to review and issue a Final Decision was to expire on November 14, 2022. On November 9, 2022, the Board issued an Order extending the deadline to issue a Final Decision an additional 45 days to December 29, 2022. Prior to that date, and having received consent of all parties, Staff now requests an additional 45-day extension of time for the Board to issue the Final Decision and in order to adequately review the record in this matter.

Considering Staff's request and the consent of the parties, I <u>HEREBY FIND</u> good cause exists for an extension of time pursuant to N.J.S.A. 52:14B-10(c) and N.J.A.C. 1:1-18.8, and as such, I <u>HEREBY ORDER</u> that the time limit for the Board to render a Final Decision is extended until February 13, 2023.²
