This matter is before the New Jersey Board of Public Utilities ("Board") concerning Board Staff's ("Staff") request for a 45-day extension of time prior to the Board issuing a Final Decision in this matter.

On May 1, 2023, the Board received Administrative Law Judge Tricia Caliguire's Initial Decision, rendering a 45-day statutory period for review and setting the date for final Board action on June $15,\,2023.^2$

On May 11, 2023, the New Jersey Division of Rate Counsel filed exceptions to the Initial Decision.

On May 15, 2023, David Amerikaner, Esq. filed exceptions to the Initial Decision on behalf of Intervenor Paul Savas and Participant Karen Martin.
