BY THE BOARD:

This matter is before the New Jersey Board of Public Utilities (“Board”) concerning Board Staff’s (“Staff”) request for a second 45-day extension of time for the Board to issue a Final Decision in this matter.

On March 5, 2024, the Board received Administrative Law Judge Gail M. Cookson’s Initial Decision, rendering a 45-day statutory period for review and thereby setting the April 19, 2024 as the date for final Board action in this matter.<sup>1</sup>

By Order dated April 17, 2024, pursuant to N.J.S.A. 52:14B-10(c) and N.J.A.C. 1:1-18.8, the Board extended the date to issue a Final Decision to June 3, 2024.<sup>2</sup> Prior to that date, and having received the consent of all parties to this matter, Staff requested an additional 45-day extension of time to adequately review the record in this matter, thereby extending the deadline for the Board to issue a Final Decision in this matter until July 18, 2024.

Considering the voluminous record in this matter and given that the parties to this matter have all consented to extending the deadline for the Board to issue a Final Decision, I **HEREBY FIND** good cause exists for an extension of time to issue a Final Decision in this matter and **HEREBY GRANT** Staff's request for an additional 45 days to adequately review the record prior to the Board rendering a Final Decision. As such, and pursuant to N.J.S.A. 52:14B-10(c) and N.J.A.C. 1:1-18.8, I **HEREBY ORDER** that the time for the Board to issue a Final Decision is extended to July 18, 2024.<sup>3</sup>




