PLEASE TAKE NOTICE that on January 30, 2024, Comcast of New Jersey II, LLC (“Comcast”) filed an application with the New Jersey Board of Public Utilities (“Board”), Office of Cable Television & Telecommunications, requesting approval to provide cable television service in the Township of Edison (“Edison”) (the “Application”). On September 18, 2023, the Board issued a system-wide franchise (“SWF”) to Comcast of New Jersey II, LLC following the conversion of its municipal franchise for the City of Perth Amboy. Comcast currently serves a total of 41 municipalities under its traditional municipal consent-based cable television franchise.
