

NOTICE OF PUBLIC HEARING
In the Matter of the Application for Renewal of a
System-Wide Cable Television Franchise for Cablevision of Oakland, LLC

PLEASE TAKE NOTICE that on December 27, 2023, Cablevision of Oakland, LLC filed an Application with the New Jersey Board of Public Utilities (“Board”), Office of Cable Television & Telecommunications, requesting the renewal of its system-wide franchise (“SWF”) to offer cable television service (“the Application”). On March 20, 2009, the Board granted a SWF to Cablevision of Oakland, LLC for a term of 7 years. Thereafter, on March 18, 2016, the Board issued a SWF renewal to Cablevision of Oakland, LLC, which expired on March 20, 2023. Cablevision of Oakland, LLC currently serves a total of 39 municipalities under its SWF, which are the subject of the Application. Additionally, the Application seeks Board approval to add two (2) additional municipalities to its SWF, the townships of Montclair and West Orange, located in Essex County, New Jersey (“the Townships”).
