

NOTICE OF PUBLIC HEARING

**In the Matter of the Application for Renewal of a
System-Wide Cable Television Franchise for Cablevision of
New Jersey, LLC BPU Docket No. CE24100829**

PLEASE TAKE NOTICE that, pursuant to the "Cable Television Act," N.J.S.A. 48:5A-16(f), the New Jersey Board of Public Utilities ("NJBP" or "Board") hereby gives notice of virtual public hearings to discuss the application of Cablevision of New Jersey, LLC ("Cablevision") for renewal of its system-wide franchise ("SWF"). On October 22, 2024, Cablevision filed an application ("Application") with the Board's Office of Cable Television & Telecommunications, requesting the renewal of its SWF to continue offering cable television service. On June 10, 2009, the Board granted a SWF to Cablevision for a term of seven (7) years. Thereafter, on March 18, 2016, the Board issued a SWF renewal to Cablevision for a term of seven (7) years, which expired on March 20, 2023. Cablevision currently serves twenty-one (21) municipalities under its SWF, which are the subject of the Application.
