

NOTICE OF VIRTUAL PUBLIC HEARING
I/M/O Renewal of a System-Wide Cable Television Franchise
CABLEVISION OF PATERSON, LLC

PLEASE TAKE NOTICE that the New Jersey Board of Public Utilities (“Board”), Office of Cable Television & Telecommunications (“OCTV&T”) has begun formal review of Cablevision of Paterson, LLC’s system-wide cable television franchise in Paterson, as provided for in 47 U.S.C. Section 546 and N.J.A.C. 14:18-14.16(b). The Board and the OCTV&T are conducting proceedings to review Cablevision of Paterson, LLC’s past performance under its system-wide franchise; and assess the future cable-related needs and interests of the City of Paterson, consistent with N.J.S.A. 48:5A-28. To that end the OCTV&T deems it necessary that a virtual public hearing be held, in conjunction with other fact-finding, to conduct the review as described above. These proceedings will allow members of the public and Cablevision of Paterson, LLC the opportunity to present their views on the Company’s system-wide franchise. Information provided at the public hearings will become part of the record of this case and will be considered by the Board in reviewing the system-wide franchise.
