TAKE NOTICE Staff of the New Jersey Board of Public Utilities ("Staff") hereby invites all interested parties and members of the public to participate in a virtual public meeting to discuss the opening of a second application ("Application") period for the Regional Greenhouse Gas Initiative ("RGGI") Medium and Heavy Duty ("MHD") Electric Vehicle ("EV") Charging Program established by Board via Order dated October 26, 2022 ("Order").¹ This will be a public information session about the RGGI MHD Charging Program and Application process. Interested parties and members of the public will have the opportunity to ask questions.

By the Order, the Board allocated \$16,150,648 in RGGI auction proceeds for MHD charging grants via the RGGI MHD EV Charging Program. Staff is opening the application for community charging for a second round to expend the remaining \$10,195,648 unencumbered during the first application round, thereby continuing the MHD RGGI program initiated by the Order.

Eligible applicants are businesses located in or primarily operating in Overburdened Communities, as defined by New Jersey's Environmental Justice Law.
