


## IN THE MATTER OF THE OPENING OF NEW JERSEY'S THIRD SOLICITATION FOR OFFSHORE WIND RENEWABLE ENERGY CERTIFICATES (OREC)

### **Docket No. QO22080481**

The New Jersey Board of Public Utilities ("BPU" or "Board") hereby gives notice of a virtual stakeholder meeting to discuss the draft solicitation guidance document ("SGD") for its third offshore wind solicitation ("Third Solicitation"). The draft SGD can be found here.

On August 19, 2010, the Offshore Wind Economic Development Act ("OWEDA") was signed into New Jersey law.<sup>2</sup> OWEDA directed the Board to establish a program for Offshore Wind Renewable Energy Certificates ("ORECs") to support at least 1,100 megawatts ("MW") of offshore wind ("OSW") generation capacity from qualified OSW projects.3

Within his first of month of taking office, on January 31, 2018, Governor Phil Murphy signed Executive Order No. 8 ("EO 8"), which directed the Board to fully implement OWEDA and begin the process of moving the State toward a goal of 3,500 MW of OSW by 2030.4 To achieve these goals, EO 8 also directed the Board to develop and implement a strategic plan to examine the critical components of OSW development.

On November 19, 2019, Governor Phil Murphy more than doubled the State's OSW goal when he signed Executive Order No. 92 ("EO 92"). EO 92 directed the Board to take "all necessary actions to implement OWEDA in order to promote and realize the development of wind energy off the coast of New Jersey to meet a goal of 7,500 megawatts of offshore wind energy generation by the year 2035."

With the clear directives from the State Legislature and the Governor, and after having adopted rules creating the OREC, on September 17, 2018 the Board issued its first OREC solicitation ("First

Solicitation"). This First Solicitation sought a target of 1,100 MW of OSW capacity. By Board Order dated June 21, 2019, the Board awarded ORECs for 1,100 MW of OSW capacity to the Ocean Wind I project.

On September 9, 2020, the Board issued its second OREC solicitation ("Second Solicitation"). The Second Solicitation sought a desired capacity target of 1,200 MW to 2,400 MW.<sup>7</sup> By two Board Orders, each dated June 30, 2021, the Board awarded two projects, 1,510 MW to Atlantic Shores 1 and 1,148 MW to Ocean Wind II.8

On September 21, 2022, Governor Murphy issued Executive Order No. 307 ("EO 307") which expanded the State's OSW goal to 11,000 MW by 2040.

To position the State to reach Governor Murphy's OSW goals, the Board formally requested inclusion of its OSW public policy into PJM Interconnection LLC's ("PJM") regional transmission expansion analysis through the State Agreement Approach ("SAA"). In October 2022, the Board approved a series of transmission projects under the SAA that provides a coordinated transmission solution for 6,400 MW of OSW generation.9

The stakeholder meeting for the Third Solicitation will be held at the following date and time, and in the following manner:
