Pursuant to the Open Public Meetings Act, N.J.S.A. 10:4-6 et seq., the New Jersey Board of Public Utilities (“NJBP” or “Board”) hereby provides notice that a Quarterly Public Meeting will be conducted in the above referenced matter.

Board Staff will provide an update on the agency’s utility assistance programs, including recent program expansions. These programs include:

- **Universal Service Fund (USF):** Provides monthly credits to eligible natural gas and electric customers;
- **Universal Service Fund – Fresh Start:** Provides energy debt forgiveness to eligible USF customers;
- **Payment Assistance for Gas and Electric (PAGE):** Provides annual grants on eligible electric and gas bills; and
- **Winter Termination Program (WTP):** Protects certain categories of customers from having their electric or gas service shut off for non-payment during the winter months (November 15 – March 15).
