

**NOTICE TO THE RESIDENTS OF MOUNT OLIVE TOWNSHIP AND OTHER
INTERESTED PARTIES OF PUBLIC HEARING**

**IN THE MATTER OF THE PETITION OF NEW JERSEY-AMERICAN WATER
COMPANY, INC. FOR APPROVAL OF A MUNICIPAL CONSENT GRANTED BY
THE TOWNSHIP OF MOUNT OLIVE, COUNTY OF MORRIS**

PLEASE TAKE NOTICE that, on January 8, 2026, New Jersey-American Water Company, Inc. (“NJAWC” or “Company”) filed an amended petition (“Petition”) with the New Jersey Board of Public Utilities (“Board”) pursuant to N.J.S.A. 48:2-14, N.J.A.C. 14:1-5.5, and such other regulations and statutes as may be deemed applicable and appropriate by the Board, for approval of a municipal consent ordinance (“Ordinance 29-2025”) granted to NJAWC by Mount Olive Township (“Township”).

The Township adopted Ordinance 29-2025 on December 23, 2025, pursuant to N.J.S.A. 48:3-11 through 48:3-15, N.J.S.A. 48:19-17 and N.J.S.A. 48:19-20, and N.J.S.A. 48:13-11, revising Ordinance No. 23-2024 adopted by the Township on August 7, 2024 and granting municipal consent to NJAWC to construct, lay, maintain and operate the necessary water mains, pipes and appurtenances throughout the Township and to provide water service and public fire protection service to a portion of the Township identified as Block 4500, Lot 5 as shown on the Tax Map of the Township (“Proposed Franchise Area”), which serves as the site of the Morris County Municipal Utilities Authority Mount Olive Transfer Station.

NO INCREASE IN RATES WILL RESULT FROM APPROVAL OF THE PETITION. If the Petition is approved, NJAWC will implement the general metered service tariff rates under Rate Schedule A-1, and private fire service rates under Rate Schedule L-1 in the Company’s Board approved tariff for the customer in the Proposed Franchise Area.

PLEASE TAKE FURTHER NOTICE that a virtual public hearing on the Petition has been scheduled for **February 20, 2026 at 10:00 a.m.**, which will be presided over by a hearing officer designated by the Board.
