### SUBCHAPTER 2. REQUIREMENTS FOR INITIAL LICENSURE

13:39-2.1 Requirements for initial licensure as a pharmacist

"Extern preceptor" means an individual approved by an [American] **Accreditation** Council [of Pharmaceutical] **for Pharmacy** Education [(ACPE) approved] **(ACPE)-approved** school or college of pharmacy, at which a pharmacy extern is enrolled, who assumes the responsibility to supervise and provide instructional training to a pharmacy extern.

## DIVISION OF GAMING ENFORCEMENT Notice of Administrative Changes General Provisions; Notice of Hourly Fees N.J.A.C. 13:69A-9.4

Effective Date: September 21, 2022.

**Take notice** that, pursuant to N.J.S.A. 5:12-141.1 and N.J.A.C. 13:69A-9.4, the Division of Gaming Enforcement (Division) shall provide notice of the hourly fee rates established pursuant to N.J.A.C. 13:69A-9.4(e)1.

To implement the Legislature's intent that the Casino Control Commission (Commission) and the Division should be financed exclusively through fees assessed upon applicants, licensees, and permit holders, N.J.A.C. 13:69A-9.4(e) authorizes the Division to determine the hourly fee rates to be paid by applicants, licensees, and permit holders. Specifically, N.J.A.C. 13:69A-9.4(e)1 provides that the hourly fee rates "shall be based upon the hourly costs of services provided by Division professional staff and the Commission professional staff during the fiscal year, as estimated from the projected fiscal year budget for the Division and the Commission."

The hourly fee rate for the Commission has not been adjusted since 2001. Its budget decreased significantly in 2012 and has remained largely flat since 2017. With a very small staff of 35, the \$82.00 per hour rate is mathematically insufficient to address the agency's expenditures. Accordingly, the rate will be standardized at \$113.00 per hour to equal that of the Division. Such hourly rate has been adjusted to limit the likelihood of future Commission revenue deficits due to the decrease in Commission staffing levels.
