RESOLUTION 2022-37
APPROVAL OF APPLICATION TO CHANGE THE BUSINESS NAME OR CONDUCT
BUSINESS UNDER AN ALTERNATE NAME

WHEREAS, P.L.2019, c.153, “Jake Honig Compassionate Use Medical Cannabis Act,” (“the Act”) authorizes a process for receipt of applications and issuance of permits to operate Alternative Treatment Centers (“ATCs”) in the state of New Jersey; and

WHEREAS, the authority to regulate and enforce activities related to medicinal cannabis previously was vested in the New Jersey Department of Health (“the Department”), and now vests in the New Jersey Cannabis Regulatory Commission (“the Commission”) pursuant to P.L. 2019, c.153; and

WHEREAS, four (4) ATCs, listed further below, have requested changes to each of their respective operating business names or alternate names; and

WHEREAS, the regulations for medicinal cannabis provide a process at N.J.A.C. 17:30A-7.8 for amendments to an Alternative Treatment Center permit, including changes to the ATC’s name; and

WHEREAS, each of these four (4) ATCs has fulfilled the requirements set forth at N.J.A.C. 17:30A-7.8; and

WHEREAS, each of these four (4) ATCs has followed the requirements set forth at N.J.A.C. 17:30A-7.1(b)(2), and have submitted documentation of a valid Business Registration Certificate on file with the New Jersey Department of the Treasury, Division of Revenue and Enterprise Services, with its new business name or alternate name.

NOW, THEREFORE, BE IT RESOLVED by the New Jersey Cannabis Regulatory Commission pursuant to N.J.A.C. 17:30A-7.8 and N.J.A.C. 17:30A-7.1(b)(2) for Amendments to Alternative Treatment Center permit, the following Alternative Treatment Centers are **APPROVED** to change their business names and/or use alternate business names as proposed in their submission to the Commission:
