WHEREAS, the regulations for personal-use cannabis provide a process at N.J.A.C. 17:30-9.2 for changes to an issued adult-use cannabis license or award, including changes of the business's name; and

WHEREAS, the one (1) conditional license awardee and four (4) annual license awardees have each followed the requirements set forth at N.J.A.C. 17:30-9.2; and

WHEREAS, each of these license awardees has submitted documentation of a valid Business Registration Certificate on file with the New Jersey Department of the Treasury, Division of Revenue and Enterprise Services with its amended business name;
