RESOLUTION 2024-~~204~~
DENIAL OF CLASS 1 CANNABIS CULTIVATOR, CLASS 2 CANNABIS
MANUFACTURER, AND CLASS 5 CANNABIS RETAILER CONDITIONAL
LICENSES

WHEREAS, the New Jersey Cannabis Regulatory Commission (“the Commission”), established pursuant to P.L.2019, c.153, known and cited as the “Jake Honig Compassionate Use Medical Cannabis Act,” is charged with implementing the provisions of that Act as well as P.L.2021, c.16, known and cited as the “New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act”; and

WHEREAS, on August 19, 2021, the Commission adopted rules pursuant to N.J.S.A. 24:6I-35(a)(1) that established the licensure process for cannabis businesses and testing laboratories; and

WHEREAS, N.J.A.C. 17:30-6 through -7 outline the application process and requirements for both conditional license applicants and annual license applicants, including eligibility requirements; and

WHEREAS, the Commission issued a Notice of Application Acceptance (“Notice”) on July 18, 2023, outlining the specific criteria for the types of applications the Commission would accept, and the dates on which the Commission would begin accepting those applications; and

WHEREAS, the Notice also outlined the specific priority by which applications would be reviewed by the Commission; and

WHEREAS, pursuant to the Notice, the Commission began accepting applications for Class 1 Cannabis Cultivator, Class 2 Cannabis Manufacturer, and Testing Laboratories licenses on December 15, 2021; and

WHEREAS, pursuant to the Notice, the Commission began accepting applications for Class 5 Cannabis Retailer licenses on March 15, 2022; and

WHEREAS, pursuant to the Notice, the Commission began accepting applications for Class 3 Cannabis Wholesaler, Class 4 Cannabis Distributor, and Class 6 Cannabis Delivery licenses for Social Equity Business applicants only on September 27, 2023; and

WHEREAS, after approval of licensure, awardees required to pay license fees for conditional licenses, as set forth in their Final Agency Decision letter and pursuant to N.J.A.C. 17:30-7.17; and

WHEREAS, awardees must pay the license fee invoice noted in their Final Agency Decision within thirty (30) days; and

WHEREAS, if the license fee invoice is unpaid after thirty (30) days, the Commission will issue the awardee a final 30-day notice to pay the invoice; and

WHEREAS, if the license fee invoice is unpaid after sixty (60) days, the awardee will be issued a notice of denial recommendation; and

WHEREAS, the below list of Class 1 Cannabis Cultivator, Class 2 Cannabis Manufacturer, and Class 5 Cannabis Retailer awardees were previously approved by the Commission for conditional licenses; and

WHEREAS, each awardee listed below received a Final Agency Decision letter setting forth post-award conditions, including the requirement to pay a license fee(s) for licenses; and

WHEREAS, the awardees listed below have not paid the requisite fees in violation of the regulatory requirements and terms of their Final Agency Decision letter;

NOW, THEREFORE, BE IT RESOLVED by the New Jersey Cannabis Regulatory Commission pursuant to N.J.S.A. 24:6I-35(a)(1) and N.J.A.C. 17:30-6 through -7, the Commission has determined to deny the following conditional license applications for failing to satisfy the requirements set forth in the regulations and the terms of their Final Agency Decision letter:
