RESOLUTION 2024-235
**APPROVAL OF APPLICATIONS TO CHANGE THE BUSINESS NAMES OF ADULT-
USE LICENSE AWARDEES AND/OR LICENSEES AND EXPANDED ATC**

WHEREAS, P.L.2019, c.153, “Jake Honig Compassionate Use Medical Cannabis Act,” (“the Act”) authorizes a process for receipt of applications and issuance of permits to operate Alternative Treatment Centers (“ATCs”) in the state of New Jersey; and

WHEREAS, the authority to regulate and enforce activities related to medicinal cannabis previously was vested in the New Jersey Department of Health (“the Department”), and now vests in the New Jersey Cannabis Regulatory Commission (“the Commission”) pursuant to P.L. 2019, c.153; and

WHEREAS, the Commission is charged with implementing the provisions of P.L.2021, c.16, known and cited as the “New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act”; and

WHEREAS, the regulations for medicinal cannabis provide a process at N.J.A.C. 17:30A-7.8 for amendments to an Alternative Treatment Center permit, including changes to the ATC’s name; and

WHEREAS, the regulations for personal-use cannabis provide a process at N.J.A.C. 17:30-9.2 for changes to an issued adult-use cannabis license or award, including changes of the business’s name; and

WHEREAS, the two (2) adult-use cannabis annual license awardees and/or licensees listed below have requested a change to each of their respective business names; and

WHEREAS, the two (2) adult-use cannabis annual license awardees and/or licensees have each followed the requirements set forth at N.J.A.C. 17:30-9.2; and

WHEREAS, the one (1) expanded Alternative Treatment Center (“expanded ATC”) listed below has requested a change to its business name; and

WHEREAS, the one (1) expanded ATC has followed the requirements set forth at both N.J.A.C. 17:30A-7.8 and N.J.A.C. 17:30-9.2; and

WHEREAS, each of the two (2) adult-use cannabis annual license awardees has submitted documentation of a valid Business Registration Certificate on file with the New Jersey Department

of the Treasury, Division of Revenue and Enterprise Services with its amended business name;
and

WHEREAS, the one (1) expanded ATC has followed the requirements set forth at N.J.A.C. 17:30A-7.1(b)(2) and has submitted documentation of a valid Business Registration Certificate on file with the New Jersey Department of the Treasury, Division of Revenue and Enterprise Services with its amended business name;

NOW, THEREFORE, BE IT RESOLVED by the New Jersey Cannabis Regulatory Commission pursuant to N.J.A.C 17:30A-7.8 and N.J.A.C. 17:30A-7.1(b)(2), concerning amendments to an Alternative Treatment Center permit, as well as pursuant to N.J.A.C. 17:30-9.2, concerning changes of the business's name, the following two (2) adult-use cannabis annual license awardees and/or licensees and one (1) expanded ATC are **APPROVED** to change their business names as proposed in their submission to the Commission:
