Nicholas Powers	Date	As a social equity licensee and receipt of a conversion to annual award, I am urging the CRC to please address waiver requests on a priority basis similar to application review, and be efficient in processing such requests. We submitted a waiver request and were told that it is up to the Chair of the CRC to decide if and when to place the matter on the agenda. The discretionary process is not only unfair it impacts my business and the timeline of my ability to become operational. If the goal of the CRC is to ensure social equity applicants are successful, then these matters need to be resolved with urgency given what's at stake. I understand the CRC has many pressing matters, but the requests of a social equity awardee should not be ignored and delayed due to discretion. There needs to be a proper mechanism in place where waiver requests are addressed promptly. The CRC does not have a November agenda/meeting, which means the earliest the request could be considered is December. We submitted our request in September. From a practical perspective, as a business owner, understand that these months of delays hurt only me and my opportunity to succeed. There is no logic in the delay and it undermines your agency's goals. To say you want to help social equity but make us wait months for a potential decision that is of paramount concern is contradictory. What we have requested of you in no way is a danger to the health or safety of others, but rather a regulatory waiver that impacts operations. Cannabis. I need to address the larger issues affecting NJ such as supply, price, municipal license availability, and maximum allowable purchase.

Outside of Dr. Zodiak's Moonrock I recently have found a 500K sqft factory facility within allowed municipal zoning that if repurposed for Licensed Cultivation according to Urban-Gro can produce over 25% of current 2024 1B a year potential NJ Supply and be occupied by 10 large Adult Use or Med licensed cultivators. There is also additional large acres of vacant land also within zoning where a 2 additionally large facilities could be built to add additional supply, manufacturing, distribution, or potentially a shopping mall of dispensaries or integrating large commercial developments of businesses or residential within cannabis zones.

The challenge is the municipality allowed 2 of each class 1-5 licenses, no 6, no testing, and no consumption zones. The 2 cultivation licenses within the municipality are available so can the facility operate as a coop of indoor cultivation under 1 municipality license with a group of NJ State Med or Adult Use licensees or even unlicensed tenants? Or would the municipality need to increase the number of municipal licenses if a Cooperative of 10 Cultivators isn't permissible. If additional cultivation licenses, as equivalent manufacturing, and retail licenses need to be obtained is there going to be any simple process for requesting a municipality to significantly increase its maximum amount of allowable licenses. If at the NJ Stare Level there are an unlimited amount of all licenses shouldn't at the municipal level there also be more adequate availability. Only available zoned activities would require more municipal licenses but perhaps the municipalities individual caps could accommodate expansion.

Institutional Caregiver Access 2024

I was disappointed that I was not able to attend the recent hearings of the New Jersey Cannabis Regulatory Commission's (CRC) Permitting and Licensing Committee (P&LC) when the need for institutional caregivers in health care facilities in New Jersey was discussed.

These hearings took place on September 25, and October 1, 2024. I applied to attend these meetings but not only was not granted permission to attend, but the meetings were not available virtually, nor is any summary publicly available, so I could not determine what issues were brought up to address the unfulfilled need for this important service.

I have testified numerous times to the CRC about the need for institutional caregivers.

"A woman told me about her 90-year-old father who is living in an assisted living facility in central New Jersey.

The director of the facility said their lawyers told him they could not have medical marijuana in their facility because they receive federal funds, and this would place those funds in jeopardy.

This patient, and many patients like him, continue to suffer needlessly by being deprived of the appropriate physician-recommended medicine due to fears that the federal government will interfere with New Jersey's medical marijuana program.

However, Congress has forbidden the Department of Justice to spend any money interfering with medical marijuana programs in any of the over three dozen such programs in the United States. The US Attorney General affirmed that they will not do so, and since then there has not been a single instance of this happening in any of the states with medical marijuana programs.

The CRC needs to reassure all facilities that house medical marijuana patients, and that receive federal funds, that they are not at risk of federal interference with New Jersey's medical marijuana program."

In testimony to the CRC on November 9, 2021, (at https://cmmnj.blogspot.com/2021/11/testimony-to-nj-cannabis-regulatory.html) I noted that "I was part of a team that tried unsuccessfully to save a patient in Status Epilepticus, an unrelenting seizure condition, at Trenton Psychiatric Hospital in the early 1970's. It was a tragic experience that I have never forgotten. It should not happen again."
