### **RESOLUTION 2026-02-12-01**

### **APPROVAL OF NOTICE OF READOPTION OF MEDICAL CANNABIS RULES**

**WHEREAS**, the New Jersey Cannabis Regulatory Commission (“the Commission”), established pursuant to P.L.2019, c.153, known and cited as the “Jake Honig Compassionate Use Medical Cannabis Act,” is charged with implementing the provisions of that Act as well as P.L.2021, c.16, known and cited as the “New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act”; and

**WHEREAS**, the rules at N.J.A.C. 17:30A establish standards and procedures governing the State’s medicinal cannabis program; and

**WHEREAS**, pursuant to N.J.S.A. 52:14B-5.1(c), the rules at N.J.A.C. 17:30A are scheduled to expire on April 27, 2026; and

**WHEREAS**, the Commission has reviewed the rules and has determined them to be necessary and proper for the purpose for which they were originally promulgated, as amended and supplemented over time, and should be readopted without amendment.

**NOW, THEREFORE, BE IT RESOLVED**, by the New Jersey Cannabis Regulatory Commission, that the attached notice of readoption is hereby approved for filing with the Office of Administrative Law, subject to the Office of the Governor granting the Commission an exemption under Executive Order No. 7.


