RESOLUTION 2026-02-12-05
APPROVAL OF PERMITTING FOR BRUTE’S ROOTS, LLC TO OPERATE A SATELLITE DISPENSARY LOCATION FOR MEDICINAL CANNABIS

WHEREAS, the authority to regulate and enforce activities related to medicinal cannabis previously was vested in the New Jersey Department of Health ("the Department"), and now vests in the New Jersey Cannabis Regulatory Commission ("the Commission") pursuant to P.L. 2019, c.153; and

WHEREAS, N.J.S.A. 24:6I-7a(2)(d)(i) authorizes an Alternative Treatment Center (“ATC”) to establish and maintain up to two satellite dispensaries, subject to NJ-CRC’s approval in accordance with N.J.S.A. 24:6I-1 *et seq.*; and

WHEREAS, in accordance with the authorities and requirements in N.J.A.C. 24:6I-1 through -30 and the corresponding rules at N.J.A.C. 17:30A-1 *et seq.*, an application for a satellite dispensary site was submitted to the Commission by:

WHEREAS, to provide consistency and uniformity in the review of applications for satellite locations submitted to the Commission, the Commission has continued the Department's process of treating satellite location approvals as a permit amendment and “change of location” under the current regulations, specifically N.J.A.C 17:30A-7.8, requiring submission of a \$10,000 fee; and

WHEREAS, Commission staff have conducted site visits and reviewed site plans for compliance with the Act, P.L.2019, c.153, and the implementing regulations pertaining to ATC operations; and

WHEREAS, Commission staff have determined that the applicants have satisfied the requirements of N.J.A.C. 17:30A-7.8 and will submit the requisite \$10,000 fee to the Commission upon approval; and

WHEREAS, based on the review, Commission staff have determined that Brute’s Roots, LLC is

authorized by N.J.S.A. 24:6I-7 to operate a satellite dispensary site, has submitted a complete application with all the necessary information required by the Commission to make a determination on the request, and has established site control and local approval for the properties and its plans;

NOW, THEREFORE, BE IT RESOLVED by the New Jersey Cannabis Regulatory Commission that the application for a satellite dispensary location for medicinal cannabis submitted by the above authorized entity is hereby approved.


