RESOLUTION 2026-02-12-14
ADMINISTRATIVE EXTENSION OF CURALEAF NJ II, INC.

WHEREAS, the authority to regulate and enforce activities related to medicinal cannabis previously was vested in the New Jersey Department of Health (“the Department”), and now vests in the New Jersey Cannabis Regulatory Commission (“the Commission”) pursuant to P.L. 2019, c.153; and

WHEREAS, pursuant to N.J.S.A. 24:6I-35(a)(1) of the Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act, N.J.S.A. 24:6I-31 et seq., (“the Act”), the Commission shall adopt rules and regulations, which include “[p]rocedures for the application, issuance, denial, renewal, suspension, and revocation of a license or conditional license to operate as a cannabis establishment, distributor, or delivery service”; and

WHEREAS, adult-use cannabis business license holders are required to submit a renewal application in compliance with N.J.A.C. 17:30-7.16; and

WHEREAS, the license of the adult-use cannabis business listed below submitted a renewal application in accordance with N.J.A.C. 17:30-7.16; and

NOW, THEREFORE, BE RESOLVED by the New Jersey Cannabis Regulatory Commission that, due ongoing litigation in the matter of Curaleaf Holdings, Inc., et al. v. N.J. Cannabis Regulatory Commission, et al. Civil Action No. 3:25-cv-16397-MAS-RLS, the Commission hereby grants an administrative extension of the Curaleaf’s personal-use license listed below until May 31, 2026, by which time the Commission will reassess whether to grant additional administrative extensions or render a final decision on the license renewal.
