RESOLUTION 2026-02-12-19

SETTLEMENT OF IMPOSITION OF SANCTIONS AGAINST GREEN ANALYTICS EAST LLC NEW JERSEY UNDER INV 126-24

WHEREAS, the New Jersey Cannabis Regulatory Commission (“the Commission”), established pursuant to P.L.2019, c.153, known and cited as the “Jake Honig Compassionate Use Medical Cannabis Act,” is charged with implementing the provisions of that Act as well as P.L.2021, c.16, known and cited as the “New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act”; and

WHEREAS, on October 7, 2024, NJ-CRC issued Green Analytics East LLC (“Green Analytics”) a Notice of Enforcement Action, imposing a civil monetary penalty of \$10,000.00 for Green Analytics' failure to adhere to the designated interim testing standards established by Resolution 2021-19 in violation of N.J.S.A. 24:61-19(e); and

WHEREAS, the parties have voluntarily agreed to settle the Notice of Enforcement Action; and

WHEREAS, the Commission now votes to act consistent with the discussion it had in executive session and the recommendation made;

NOW, THEREFORE, BE IT RESOLVED, by the New Jersey Cannabis Regulatory Commission, that the settlement agreement with Green Analytics under INV 126-24 is hereby approved. **It is FURTHER RESOLVED** that the Chair and Executive Director have joint authority to sign the agreement on behalf of the Commission.
