**RESOLUTION 2026-02-12-20**  
**SETTLEMENT OF IMPOSITION OF SANCTIONS AGAINST GARDEN SOCIETY NJ LLC UNDER**  
**INV 207-24**

**WHEREAS**, the New Jersey Cannabis Regulatory Commission (“the Commission”), established pursuant to P.L.2019, c.153, known and cited as the “Jake Honig Compassionate Use Medical Cannabis Act,” is charged with implementing the provisions of that Act as well as P.L.2021, c.16, known and cited as the “New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act”; and

**WHEREAS**, on April 10, 2025, NJ-CRC issued Garden Society NJ LLC (“Garden Society”) a Notice of Enforcement Action, imposing a civil monetary penalty of \$8,000.00 for Garden Society’s failure to ensure that its employees had properly cleared the background check process and been issued a cannabis business identification card in violation of N.J.A.C. 17:30-8; and

**WHEREAS**, the parties have voluntarily agreed to settle the Notice of Enforcement Action; and

**WHEREAS**, the Commission now votes to act consistent with the discussion it had in executive session and the recommendation made;

**NOW, THEREFORE, BE IT RESOLVED**, by the New Jersey Cannabis Regulatory Commission, that the settlement agreement with Garden Society under INV 207-24 is hereby approved. **It is FURTHER RESOLVED** that the Chair and Executive Director have joint authority to sign the agreement on behalf of the Commission.
