RESOLUTION 2026-07-16-07
ADMINISTRATION EXTENSION OF CURALEAF NJ, II, INC'S ADULT-USE CANNABIS
BUSINESS LICENSES AND MEDICINAL PERMITS

WHEREAS, P.L.2019, c.153, “Jake Honig Compassionate Use Medical Cannabis Act,” (“the Act”) authorizes a process for receipt of applications and issuance of permits to operate Alternative Treatment Centers (“ATCs”) in the state of New Jersey; and

WHEREAS, the authority to regulate and enforce activities related to medicinal cannabis previously was vested in the New Jersey Department of Health (“the Department”), and now vests in the New Jersey Cannabis Regulatory Commission (“the Commission”) pursuant to P.L. 2019, c.153; and

WHEREAS, pursuant to N.J.S.A. 24:6I-35(a)(1) of the Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act, N.J.S.A. 24:6I-31 et seq., (“the CREAMM Act”), the Commission shall adopt rules and regulations, which include “[p]rocedures for the application, issuance, denial, renewal, suspension, and revocation of a license or conditional license to operate as a cannabis establishment, distributor, or delivery service”; and

WHEREAS, the Commission approved and issued licenses and medical permits to the following Expanded ATCs:

WHEREAS, the regulations for medicinal cannabis provide a process at N.J.A.C. 17:30A-7.6 and N.J.A.C. 17:30A-7.7 for renewals of ATC permits; and

WHEREAS, adult-use cannabis business license holders are required to submit a renewal application in compliance with N.J.A.C. 17:30-7.16; and

WHEREAS, Curaleaf NJ II Inc. has submitted renewal applications;

NOW, THEREFORE, BE IT RESOLVED by the New Jersey Cannabis Regulatory Commission that, due ongoing litigation in the matter of Curaleaf Holdings, Inc., et al. v. N.J. Cannabis Regulatory Commission, et al. Civil Action No. 3:25-cv-16397-MAS-RLS, the Commission hereby grants an administrative extension of the Curaleaf’s personal-use licenses and medicinal cannabis permits listed below to **October 31, 2026**, by which time the Commission will reassess whether to grant additional administrative extensions or render a final decision on the license renewal:
