RESOLUTION 2026-07-16-13
SETTLEMENT OF IMPOSITION OF SANCTIONS AGAINST
NEW JERSEY CANNALYTICS LLC UNDER INV 102-25

WHEREAS, the New Jersey Cannabis Regulatory Commission (“the Commission”), established pursuant to P.L.2019, c.153, known and cited as the “Jake Honig Compassionate Use Medical Cannabis Act,” is charged with implementing the provisions of that Act as well as P.L.2021, c.16, known and cited as the “New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act”; and

WHEREAS, on February 19, 2026, NJ-CRC issued New Jersey Cannalytics LLC (“New Jersey Cannalytics”) a Notice of Enforcement Action, imposing a civil monetary penalty of \$25,000.00 for transporting cannabis from its NJ-CRC licensed location to its unlicensed location in Westminster, Maryland where heavy metal testing of the cannabis was performed, and for failing to report changes in its testing methodology for sampling and lab procedures in violation of ISO 17025 reporting practices, N.J.S.A. 24:6I-18(a)(1) and N.J.A.C. 17:30-18.5(e)(2); and

WHEREAS, the parties have voluntarily agreed to settle the Notice of Enforcement Action; and

WHEREAS, the Commission now votes to act consistently with the discussion it had in executive session and the recommendation made;

NOW, THEREFORE, BE IT RESOLVED, by the New Jersey Cannabis Regulatory Commission, that the settlement agreement with New Jersey Cannalytics to resolve INV 102-25 is hereby approved. **It is FURTHER RESOLVED** that the Chair and Executive Director have joint authority to sign the agreement on behalf of the Commission.
