Introduction

Calendar year 2023 was the third year the New Jersey Cannabis Regulatory Commission assumed all duties, powers, and responsibilities for oversight of medicinal cannabis activities from the New Jersey Department of Health, in accordance with N.J.S.A. 24:6I-24.

While there was an increase in the number of Alternative Treatment Centers (ATCs) and there continues to be new patients enrolling (almost 16,000), there has been a decline in the active patient rolls. The number of active patients at year's end was down 21% to 91,247, as compared to 2022. This reduction in the Medicinal Cannabis Program participation is typical of state programs upon the opening of an adult-use cannabis market.

The number of healthcare providers and caregivers, however, did not see the same decline. The number of active caregivers rose 5% over 2022 to 5,370. The program also added 105 new health care providers in 2023. The program served patients with 18 different qualifying conditions, including more than 56,000 patients suffering from anxiety.

This report details the statistics and major developments in the program for the calendar year 2023 and provides details on NJ-CRC's budget and regulatory process for cannabis activities.

Reduction and Elimination of Patient Registration and Renewal Fees

New patients and existing patients and caregivers in the Medicinal Cannabis Program (MCP) saw renewal fees fall to just \$10 for a two-year registration, from \$50 for most registrants and \$20 for reduced fees.

Cannabis Consumption Areas

The Commission updated its regulations to include rules for cannabis consumption areas and began taking public comment. The cannabis consumption area rules have an allowance for medicinal patients to bring in products they have purchased at another facility.

Clinical Registrant Rule Proposal

On June 21, 2023, the NJ-CRC proposed new rules governing clinical registrants.

Waiver to Offer Additional Ingestible Forms of Cannabis Products

On September 8, 2023, the NJ-CRC issued a waiver to allow for additional ingestible products to be produced for patients by permitted medicinal cannabis manufacturers. The waiver allows for the manufacture of shelf stable (or non-TCS) food items (such as chocolates, gummies, baked goods, butters, jams, and jellies) that do not require time or temperature control to limit pathogenic microorganism growth or toxin formation. The waiver also permits the operators to produce beverages with no more than 5 mg of total THC per single serving.

Patient Survey

A survey conducted by NJ-CRC staff in 2023 gathered 1,098 responses from the Medicinal Cannabis Program, representing a sample size large enough to make accurate inferences about the entire registered patient population. The primary concerns expressed by respondents were the high cost of cannabis, high doctor fees, frustration with the registration process with a single ATC, inconsistent product availability, lack of product variety, and the maximum monthly allotment. Additionally, the survey highlighted a lack of user familiarity and dissatisfaction with the patient registry portal, which is used to register and track patients, caregivers, and health care professionals.

Despite the noted issues, the survey also highlighted expressions of gratitude for the program, with many participants acknowledging that they have never had problems contacting the Commission's patient services. Overall, very few complaints were recorded, suggesting a generally positive sentiment from the respondents towards the NJ-CRC's Medicinal Cannabis Program.

Patient Registration Clinics

In 2023, the NJ-CRC conducted patient registration clinics in Trenton, Newark, and Bridgeton as part of ongoing efforts to support New Jersey's Medicinal Cannabis Program. The pilot program, led by the agency's Patient Services Unit and Office of Diversity and Inclusion, provided services to assist patients with program registration and renewal. These services included providing guidance for new registration and renewal, offering support for required document submission, and assisting with caregiver changes, address updates, and processing payments. The approach focused on targeting areas with high patient enrollments, addressing enrollment challenges, and ensuring clinic accessibility by selecting clinic locations with access to major public transportation lines and ADA compliance.

Despite comprehensive services and support, the 2023 clinics experienced lower-than-desired turnout, having served just over a dozen patients and caregivers. Feedback about the patient registration clinics, however, was invaluable and consistent among all three locations. Patients who were served indicated that without the clinics they would have been unable to complete the necessary program registration and enrollment.

Budget

The total budget expenditure for the New Jersey Cannabis Regulatory Commission in 2023 was \$10,716,597.49.

Figure 1: Nature of Patients Qualifying Conditions 2023




Figure 2: 2023 Healthcare Providers Enrolled in Medicinal Cannabis Program, by Specialty



Figure 3: Patients by Age Group Bar Chart




Figure 4: Patients Gender Breakdown Pie Chart



Figure 5: Active Patients by County




Figure 6: Active Patients by County (Descending Order)
