Subsequent to the reading of a statement of compliance with the notice requirements of the Open Public Meetings Act and identification of items discussed during closed session, the Commission considered and took formal action on the following matters:

- 1. By votes of 3-0, ratified the minutes of August 8, 2012 (transcript page 6).
- 2. By a vote of 3-0, granted the applications of Thomas Battista, Candace E. Brown, Adam J. Faris, Julie L. Grabowski, Joseph L. Griffin, John L. Katapodis, Maryanne T. Klemmer, Delora J. LoDuca, David E. Manning, William J. Perry, David M. Reccoppa and Livingston N. Simpson for initial casino key employee licenses (Exhibit EL-1\*;transcript page 8-9).
- 3. By a vote of 3-0, granted the resubmitted applications of Paul J. Bohrer, Daniel J. Cummings, Joseph M. Desimone, Ming M. Flesch, Pamela A. Garman, Anthony C. Grover, Phyllis J. Guerra, George S. Herse, William R. Hopper, John H. Houston, Sherlene L. Hurd, Kenneth J. Karpolorich, Gloria Leader, Francis X. McCarthy, Jr., Glenn Mercado, James E. O'Keefe, Joseph T. 4. Considered the applications for casino key employee licenses and for qualification and issued the following rulings:

By a vote of 3-0, granted the casino key employee license application of Eleni Lemoniotis and for qualification as Director of Internal Audit and Compliance for Trump Taj Mahal Associates, LLC (Ruling number 12-09-12-03-A);and

By a vote of 3-0, granted the casino key employee license application of Joseph C. Watson and for qualification as Vice President of National Marketing for Boardwalk Regency Corporation (Ruling number 12-09-12-03-B; transcript pages 11-13).

Chairman Levinson stated on the record that the Commission is committed to expediting requests for temporary licenses through a streamlined procedure and has notified the proper Casino General Managers and Casino Counsels (transcript page 14).

By a vote of 3-0, approved the petition of Marina District Development Company, LLC (d/b/a Borgata Hotel Casino & Spa), and issued a temporary casino key employee license to Rebecca Schultz, pursuant to *N.J.S.A.* 5:12-89(e) and permitted her, pursuant to *N.J.A.C.* 13:69c-2.7 (c ), to assume the duties and exercise the powers of Vice President of Food and Beverage for Marina District Development Company, LLC, pending plenary licensure and qualification. - 7. By a vote of 3-0, granted the requested relief and inactivated the casino key employee licenses held by Steven A. Ball, Robert B. Bell, John M. Derichie, Judith S. Kremer, Nicholas J. Lapergola, Jane J. Lock, Martha McGowan, Albert P. Renzulli, Jr., Michael A. Souza, Michael W. Stevens and Donna White (Ruling number 12-09-12-07-A; 12-09-12-07-B; 12-09-12-07-C; 12-09-12-07-D; 12-09-12-07-E; 12-09-12-07-F; 12-09-12-07-G; 12-09-12-07-H; 12-09-12-07-I; 12-09-12-07-J; 12-09-12-07-K; transcript pages 16-18).

- 8. By a vote of 3-0, approved the stipulation of Deborah Sherman and issued the following rulings:
  - a) vacated the Commission's Order dated September 1, 2010, suspending the respondent's casino key employee license; and
  - b) removed the respondent's name from the restricted list

- 9. By a vote of 3-0, found Eileen A. Moore qualified to serve as a member of the Capital Committee of Caesars Entertainment Corporation, in accordance with <u>N.J.S.A.</u> 5:12-85.1c, <u>N.J.S.A.</u> 5:12-89b (1), <u>N.J.S.A.</u> 5:12-89b (2) and *N.J.A.C.* 13:69C-2.7 (ruling number 12-09-12-09; transcript pages 20-22).
- 10. Petition of DGMB Casino, LLC and MGA Gaming NJ, LLC for approval of a Management Agreement, pursuant to <u>N.J.S.A.</u> 5:12-82c (DGE PRN 2301201) has been adjourned to September 14, 2012 (transcript page 22).
- 11. Petition of MGA Gaming NJ, LLC for a determination of status as a Casino Service Industry Enterprise, pursuant to *N.J.S.A.* 5:12-92a (DGE PRN 2301202) has been adjourned to September 14, 2012 (transcript page 22).
