- 6. By a vote of 3-0, granted the requested relief and inactivated the casino key employee licenses held by John P. Burke, Medio Demarco, Jr., William J. Demko, III, Lucretia A. Fetcho, Debra L. Karver, Kevin E. McHugh, Linda K. Peditto, Michael C. Tabasso, Elizabeth E. Ward, Kenneth E. Warner Jr. and Raymond A. Wittschen, III (Ruling number 13-04-10-06-A; 13-04-10-06-B; 13-04-10-06-C; 13-04-10-06-D; 13-04-10-06-E; 13-04-10-06-F, 13-04-10-06-G, 13-04-10-06-H, 13-04-10-06-I, 13-04-10-06-J, 13-04-10-06-K; transcript pages 15-17).
- 7. By a vote of 3-0, approved the termination of the casino key employee licenses held by Maryann S. Bair, Rosa D. Bermudez, Diana G. Carrion-Apicella, Joyce E. Copeland, John P. Copple, Michael P. May, Joseph P. Meloni, Janet M. Miller, Rosemary T. Reale

and Tracey L. White-Almeida (Ruling numbers 13-04-10-07-A; 13-04-10-07-B; 13-04-10-07-C; 13-04-10-07-D, 13-04-10-07-E, 13-04-10-07-F, 13-04-10-07-G; 13-04-10-07-H; 13-04-10-07-I, 13-04-10-07-J; transcript pages 17-18).

- 8. By a vote of 3-0, approved the stipulation of settlement and granted the application of Kristine F. White, for a casino key employee license, subject to compliance with certain financial and reporting conditions, as provided for in the stipulation (DKT 13-0002-CK) (Ruling number 13-04-10-08; transcript pages 18-20).
- 9. Considered the Complaint for Revocation in State v. Wilson G. Orrego and issued the following ruling:

By a vote of 3-0, found Wilson G. Orrego disqualified, and revoked his casino key employee license. Mr. Orrego is prohibited from applying for or holding any license, registration, qualification, or approval required under the Act, except as provided for in the Order (DKT 13-0004-CK) (ruling number 13-10-04-09; transcript pages 20-22).

- 10. By a vote of 3-0, adopted the draft resolution and found Wilbur H. Mathesius, qualified to serve as a Member of the Independent Audit Committee of RIH Acquisitions NJ, LLC, in accordance with *N.J.S.A.* 5:12-85.1c, *N.J.S.A.* 5:12-85.1d, *N.J.S.A.* 5:12-89b(1), *N.J.S.A.* 5:12-89b(2) and *N.J.A.C.* 13:69C-2.7 (Ruling number 13-04-10-10; transcript pages 22-25).
- 11. By a vote of 3-0, adopted the draft resolution and found Frederick P. DeVesa, qualified to serve as a Member of the Independent Audit Committee of RIH Acquisitions NJ, LLC, in accordance with <u>N.J.S.A.</u> 5:12-85.1c, <u>N.J.S.A.</u> 5:12-85.1d, <u>N.J.S.A.</u> 5:12-89b(1), <u>N.J.S.A.</u> 5:12-89b(2) and <u>N.J.A.C.</u> 13:69C-2.7 (Ruling number 13-04-10-11; transcript pages 25-28).
- 12. Considered the Joint Petition of Bally's Park Place, Inc. (d/b/a Bally's Atlantic City), Boardwalk Regency Corporation (d/b/a Caesar's Atlantic City), Harrah's Atlantic City Operating Company, LLC (d/b/a Harrah's Resort Atlantic City) and Showboat Atlantic City Operating Company, LLC. (d/b/a Showboat Casino Hotel) and issued the following ruling:

By a vote of 3-0, approved the joint petition and granted Michele McCants, a multi casino endorsement to her casino key employee license, pursuant to *N.J.S.A.* 5:12-91.1 for Bally's Park Place, Inc., Boardwalk Regency Corporation, Harrah's Atlantic City Operating Company, LLC and Showboat Atlantic City Operating Company, LLC (PRN 0801304) (13-04-10-12; transcript pages 28-31).
